Club Presidents and Club Treasurers:

For most clubs, your fiscal club year has just ended and the one thing you should not neglect is your taxes. If your fiscal year ended December 31st, your taxes were due May 15 and although you will be a little late, file these taxes now. For those clubs whose year ended May 31st, you have until October 15 to file, but for so many of us, by then the task is forgotten.

There is a new form for the Attorney General this year CR-TR-1, complete information about this form can be found on the California Attorney General's website. Also check to see if this is your year to file the SI-100 with the Attorney General, this form is filed every other year.

Below is the annual tax filing information, be sure to read it.

DISTRICT & CLUB TREASURER'S ANNUAL TAX FILING INFORMATION

Following the end of the club's fiscal year (May 31st or December 31st), clubs are required to file the following tax forms:

For all of the following you need the following:

- 1. EIN number, also known as a Taxpayer Identification Number (a 9-digit number NN-NNNNNN)
- 2. Legal name and mailing address of your club
- 3. Name and address of the principal officer
- 4. Web site address if the club has one
- 5. Confirmation of the organization's annual gross receipts

1. California e-Postcard (Form 199N)-CA State Taxes

File electronically

Clubs with gross receipts over \$25,000 need to file Form 199N or 199N-EZ annually Website: ca.gov (under "search", type in Form 199N) CA ID required logging into the site: This is a 7-digit number without a dash FEIN ID required: Located on CFWC's web site under "Members"

2. IRS (Form 990-N) e-postcard—Federal Taxes

File electronically

Due annually by the 15th day of the 5th month after close of fiscal year (Oct. 15th or May 15th) Website: <u>https://www.irs.gov/charities-non-profits</u> Log-on ID: will be required as you set up the account Pass Word: required

3. Attorney General of California-Registry of Charitable Trusts (Form RRF-1)

File electronically

Gross Annual Revenue: Less than \$25,000 filing fee is \$0

Gross Annual Revenue: Between \$25,000 and \$100,000 filing fee \$25 a check must be submitted with completed form. This now requires reporting noncash donations.

Website: http://oag.ca.gov/charities

CA ID: This number might be found on <u>http://oag.ca.gov</u>; then search "Charities in good standing registry". This number is stamped on the organization's articles of incorporation.

4. Attorney General Of California-Registry of Charitable Trusts (NEW Form CT-TR-1)

File electronically Gross Annual Revenue less than \$50,000 and must report noncash donations. Website: <u>http://oag.ca.gov/charities</u> State Charity registration number required This is now as filebraum 2, 2020 and there is a first the last the file

This is new as of February 2, 2020 and there is a fee attached to the filing.

5. Statement of information (Form SI-100)—CA Secretary of State

File electronically—in some cases a 990-EZ can be filed with the Attorney General's office in lieu of this new form.



I am sure in doing so that you will find something in your bylaws that you either had forgotten or are learning for the first time. Consider using a highlighter to make note of anything you would like to ask your clubs' Parliamentarian about. Take an interest in understanding how your bylaws helps your club in fairness to its members by spelling out the responsibilities of its officers and how meetings are to be run.

Your bylaws are the fundamental rules that define your club. They are not able to be changed unless the members get previous notice of any proposed change, and a large majority (commonly 2/3) is required to enact any proposed change(s).

GFWC encourages all of us to preserve the world's resources, protect wildlife and domesticated animal, live sustainably, enjoy nature, and beautify our communities. GFWC Challenge Project is reduce plastic use, refuse, reuse, repurpose, and recycle. I hope all of you subscribe to CFWC QuickBytes because there was a very interesting article by CFWC Environment Chair, Joan Thomey, related to honey bees. I never realized how important honey bees were until I read this information. August 15th is national Honey Bee Day! The USDA officially reserved this day to honor this remarkable insect responsible for pollinating the foods that comprise 1 in every 3 bites we consume in this country. Here are a few suggestions to **Save the Honeybee**...

*Work with your nursery professional to select bee friendly plants.

*Avoid using herbicides and pesticides. Look for alternative ways to deal with pests and disease issues.

*Bees need a place to get fresh water. Maintain a shallow container of water with pebbles for the bees to land on while drinking.

Hello SGVD Members, My name is Christina. I am a transformation coach and a member of Santa Fe Springs Women's Club. I am grateful to be your Health and Wellness Community Service Representative. There are several organizations in the month of September to be aware of, however, with the growing pandemic of Covid-19, I would love to take the time to emphasize the importance of staying healthy. Eating healthier, keeping blood pressure down, and getting our bodies to a healthy BMI, are all factors in how the virus impacts the body. Making small changes will definitely help. Take a walk outside for 30 minutes (Start small with maybe just 10 minutes/day) Cut down on carbs. Swap zucchini spirals for pasta, using lower fat meat or substituting ground turkey for ground beef can definitely help. Here is a fun recipe to make for the family. Be mindful to stay away from carbs (bread, tortillas, rice, potatoes, and pastas) add low-carb vegetables to daily meals and the benefits will show.

Instant Pot Chipotle Chicken and C	auliflower Rice Bowls: (yields 4)
Ingredients:	Directions:

2020-2022 Legislation & Public Policy Advancement Plan Activity in an Election Year July 2020

AVOCACY, ELECTIONS AND THE 501 C3 ORGANIZATION GFWC has a rich tradition of advocacy and that is unlimited for 501c3 organizations. What can you do to *Rock the Vote*!

Make sure all members of your club are registered. Educate women on the importance of exercising their voting rights. You may facilitate voting using mail, early voting sites curbside voting and absentee voting.

Learning about issues and educating others is a vital part of our legislative agenda. It is not true that 501c3's must avoid lobbying (influencing legislation or legislators). Care is required as to amount of lobbying. Expenses are reported on IRS forms. When you sign in to the Legislative Action Center, GFWC reports that activity.

However, your club can advocate and educate, hold virtual forums (all candidates must be invited), encourage registration and voting. Remember you can advocate and educate for issues but not for people. Clubs can't endorse candidates for publicly elected office or donate to political campaigns. (This doesn't infringe on your personal rights to participate in the political process.) Do not waste this hard fought for "right".

You can locate them on line at: National Women's History Alliance. They have books, posters, pins, stickers, jewelry, PowerPoints, speeches, current and historical events, and so much more. NWHA is actually located in Santa Rosa, California. They were very active in the Rose Parade Float, Pasadena Celebrates 2020 "Years of Hope, Years of Courage," celebrating 100 years of women's suffrage. "In keeping with an expanded online presence and the promotion of the 2020 Women's Suffrage Centennial, the National Women's History Alliance is proud to announce Volume 2 of the "Women Win the Vote" Gazette, now available for free download....

Despite the interruption of the pandemic, celebrations of women's historic achievement in winning the 19th Amendment will not be silenced. Suffragists too, faced a deadly virus – and a war – while trying to win the key state of New York in 1917. Their strength is our inspiration. This updated 28-page "Women Win the Vote" Gazette is a treasure chest. It is full of national news, leads to groups in every state and hundreds of links to exceptional women's history and suffrage-related resources.

There are listings and links to museum shows and websites, educational projects, toolkits, statues and memorials, historic sites, online exhibits and curriculum, special educational and voting projects, plays, musicals, films, videos, books, suffrage music, songwriters, artists, performers and more. "Women Win the Vote" also includes articles on Iroquois and Black women, short biographies of 100 Suffragists, and a host of products that celebrate the centennial. Women Change the World - Discovering and Using our Power

In honor of the 100th anniversary of women winning the right to vote the Diamond Bar Woman's Club in the San Gabriel Valley District created a video remembering the 72 year struggle to gain passage of the 19th amendment.
