Bylaws and Standing Rules are a Big Deal – So what is up with the Process?

Let me preface the conversation about proposed changes to Bylaws and Standing Rules by saying nothing is ever perfect and no matter what, some people will not be happy. Only the two thirds vote by the group has the power to adopt or reject any proposed change.

Our Bylaw Committee has met, discussed, advised and approved of the development of proposed changes to our Standing Rules and Bylaws. As you saw at our December Executive Board meeting we are trying something new to allow more time for members to study, discuss and have input into the final changes to be made. In December I reviewed the timeline we will be following, gave a short summary of the proposed changes and members were provided with copies of the proposed changes to our Standing Rules. Those proposed changes are also included in the January Key.

At Birthday Council members will be given an opportunity to discuss the proposed changes to Standing Rules. They will also get a printed copy of the proposed changes to our Bylaws. The Bylaws changes will be printed in the February Key, the March Key and in the Convention Call. In February there will be a motion to approve the proposed changes to the Standing Rules. This will be by acclamation. That means the vote on the proposed changes to Standing Rules would happen all at once without reading each proposed change. After the motion and the second anyone can make a motion that asks for any controversial proposal to be pulled from the acclamation vote. This motion needs a second and the standard debate process as well as a vote. Should the motion to pull specific proposals pass, the remainder of the proposals that were not asked to be dealt with separately will proceed in a vote by acclamation. The next step would be to read each of the items that were pulled and make individual motions, seconds, debates and votes on each.

Also, in February members may discuss the proposed Bylaws changes that were included in Call and the February Key and distributed at Birthday Council. This discussion does not include a motion and for efficiency sake we will allow members to speak for 2 minutes, rotated between pro and con. Each member can only speak twice and the second time is only after all first time speakers have had a chance. There will be another time to discuss the proposed Bylaw changes at the March meeting.

A great deal of what is included in the proposed changes will not change our personal lives, mortally wound anyone or create an ethical dilemma the would cause people to lose sleep over. Given this, I would suspect that many people will lose interest and/or get angry should the efforts to give members the opportunity to have input go on and on forever.

Ladies, if you have objections, please pick your battles! We all want to take care of business and then go out to lunch.

San Gabriel Valley District of Women's Clubs **Proposed Bylaw Changes for 2023**

Article VI – Officers and their Duties

Propose adding new Section 11: *The president at their discretion may appoint an historian, a librarian, a curator, a chaplain, a sergeant-at-arms and/or a doorkeeper.*

Rationale: Presidents may need help in a variety of areas. All of the proposed options come from suggestions in Robert's Rules 47:40.

If amended Section 11 shall read: The president at their discretion may appoint an historian, a librarian, a curator, a chaplain, a sergeant-at-arms and/or a doorkeeper.

ARTICLE VII – Executive Board

Section 9 Now Reads: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, at the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other. The notice of the electronic meeting must include adequate description of how to participate in it.

Proposed Section 9: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. ~~The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other.~~ The notice of the electronic meeting must include adequate description of how to participate in it.

Rationale: Our experience with the use of electronic meetings has demonstrated that many meetings can be successfully conducted electronically and that this option often allows for more members to be able to participate in meetings.

If Amended Section 9 Would Read: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. The notice of the electronic meeting must include adequate description of how to participate in it.

ARTICLE VIII – Executive Committee

Section 10 Now Reads: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, at the discretion of the President and approval of the Executive Committee, ~~the Executive Committee and/or Executive Board~~ meetings may be conducted electronically. The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other. The notice of the electronic meeting must include adequate description of how to participate in it.

Proposed Section 10: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, the Executive Committee and/or Executive Board meetings may be conducted electronically. ~~The application used to conduct electronic meetings must allow all participating members to see each other, as well as to hear each other.~~ The notice of the electronic meeting must include adequate description of how to participate in it.

Rationale: Our experience with the use of electronic meetings has demonstrated that many meetings can be successfully conducted electronically and that this option often allows for more members to be able to participate in meetings.

If Amended Section 10 Would Read: In the event of national, state or local emergencies, man-made or natural, which could potentially put members in danger, At the discretion of the President and approval of the Executive Committee, ~~the Executive Committee and/or Executive Board~~ meetings may be conducted electronically. The notice of the electronic meeting must include adequate description of how to participate in it.

Article XI – Annual Meeting/Convention

Section 5 Now Reads: A delegate shall represent but one (1) Club and shall have one (1) vote. Voting proxy, either written or verbal, shall not be permitted. A Club President who attends a convention, including the Federated/Affiliate Groups, who holds a District/SGVD, State or General Federation Office or Chairpersonship, or is a Past District/SGVD President of San Gabriel Valley District/SGVD, shall represent her Club as a delegate to convention and the Spring Council in an election year.

Proposed Changes: A delegate shall represent but one (1) Club and shall have one (1) vote. Voting proxy, either written or verbal, shall not be permitted. ~~A Club President~~ An Executive Board Member who attends a convention, including the Federated/Affiliate Groups, who holds a District/SGVD, State or General Federation Office or Chairpersonship, or is a Past District/SGVD President of San Gabriel Valley District/SGVD, shall ~~represent her Club~~ represent their highest position as a delegate to convention and the Spring Council in an election year. Should they also have a vote as an officer or delegate from their Club, the Club shall assign an alternate delegate.

Rationale: The new language accurately describes the delegate/voting practices that have been followed by the District for the past many years. If the currently Bylaw language was in fact used, there would be a voting penalty for any Club with a voting delegate that also was a member of the SGVD Executive Board, a State or General Federation Officer or Chairpersonship, a past District/SGVD President or an Federated/Affiliate Group President. In

addition to the new language being the accurate representation of the District's past practice, it is the same delegate/voting structure used by the CFWC.

If Amended Section 5 Will Read: A delegate shall represent but one (1) Club and shall have one (1) vote. Voting proxy, either written or verbal, shall not be permitted. An Executive Board Member who attends a convention, including the Federated/Affiliate Groups, who holds a District/SGVD, State or General Federation Office or Chairpersonship, or is a Past District/SGVD President of San Gabriel Valley District/SGVD, shall represent their highest position as a delegate to convention and the Spring Council in an election year. Should they also have a vote as an officer or delegate from their Club, the Club shall assign an alternate delegate.

Article XII – Nominations

Section 2 now reads: At Fall Executive Board or Council meeting prior to the annual meeting in an election year, the Executive Board shall elect an Election Board of five members and two alternates, none of whom shall be members of the Executive Board, and a Nominating Committee of five members and two alternates all of whom shall be members of the Executive Board. Alternates to both the Nominating Committee and the Election Board shall participate as observers at all meetings and step in as official active members as needed. The Election Board and Nominating Committee shall not have a majority of members from a single club.

Proposed Addition to Section 2: *Members of the Nominating Committee of the San Gabriel Valley District of Women's Clubs/SGVD cannot serve two consecutive terms.*

Rationale: To support a fair and open nominating process.

If amended Section 2 will then read: At Fall Executive Board or Council meeting prior to the annual meeting in an election year, the Executive Board shall elect an Election Board of five members and two alternates, none of whom shall be members of the Executive Board, and a Nominating Committee of five members and two alternates all of whom shall be members of the Executive Board. Alternates to both the Nominating Committee and the Election Board shall participate as observers at all meetings and step in as official active members as needed. The Election Board and Nominating Committee shall not have a majority of members from a single club. Members of the Nominating Committee of the San Gabriel Valley District of Women's Clubs/SGVD cannot serve two consecutive terms.

Article XII – Nominations

Section 7 Now Reads: Nominations from the floor at Spring Council shall be limited to nominees qualifying under the sections listed in these bylaws.

Proposed Section 7: *Nominations from the floor for any elected position on the Executive Committee of the San Gabriel Valley District of Women's Clubs/SGVD shall be limited to nominees qualifying under the sections listed in these bylaws. Nominations from the floor may be made at any official meeting of the San Gabriel Valley District of Women's Clubs/SGVD after the slate of candidates is presented to the Executive Board by the Chairman of the Nominating Committee.*

Rationale: Roberts Rules 46:18 states that the Chair must call for nominations from the floor at the session at which the elections takes place. It also states that nominations from the floor may be made after the Nominating Committee has presented its proposed slate and before the election. Many

organizations allow this flexibility to increase member input into the nominating process. This will also make it easier for the names of those nominated from the floor to be printed on the ballot.

If amended will then read: Nominations from the floor for any elected position on the Executive Committee of the San Gabriel Valley District of Women’s Clubs/SGVD shall be limited to nominees qualifying under the sections listed in these bylaws. Nominations from the floor may be made at any official meeting of the San Gabriel Valley District of Women’s Clubs/SGVD after the slate of candidates is presented to the Executive Board by the Chairman of the Nominating Committee.

Article XII – Nominations

Proposed Section 8: *Members of the San Gabriel Valley of Women’s Clubs/SGVD submitting their name for nomination, selected by the Nominating Committee for nomination and/or nominated from the floor for a financial position be required to include in the documents they submit examples of their job experience or financial education prior to being placed on the ballot. Should a financial officer be required to be bonded, they must meet the qualifications of the bonding agency prior to being allowed to fill the position.*

Rationale: The San Gabriel Valley District of Women’s Clubs (SGVD) engages in a significant amount of fund raising which requires the officers responsible for the finances to have appropriate skills, abilities and experiences.

If amended will then read: Members of the San Gabriel Valley of Women’s Clubs/SGVD submitting their name for nomination, selected by the Nominating Committee for nomination and/or nominated from the floor for a financial position be required to include in the documents they submit examples of their job experience or financial education prior to being placed on the ballot. Should a financial officer be required to be bonded, they must meet the qualifications of the bonding agency prior to being allowed to fill the position.

Article XIII – Elections

Proposed new add Section 5 and renumber as needed: *The names of all members nominated by the Nominating Committee or nominated from the floor for a San Gabriel Valley District (SGVD) office shall have their names printed on the ballot prior to distribution of the ballots and prior to the start of voting. A place for the name of a write in candidate for each office shall appear on the ballot.*

Rationale: This change will allow all members who are nominated to be treated equally and provided an equal opportunity to be elected. It also allows the SGVD to conform to the procedures of the General Federation of Women’s Clubs (GFWC) -- California Federation of Women’s (CFWC). Also, Roberts Rules 46:18 states “on a ballot vote in an election or other voting involving multiple possible choices, members are able to write in or fill in a vote for any eligible person or choice and are not confined to voting for or against candidates that appear on the ballot.”

If amended will then read: The names of all members nominated by the Nominating Committee or nominated from the floor for a San Gabriel Valley District (SGVD) office shall have their names printed on the ballot prior to distribution of the ballots and prior to the start of voting. A place for the name of a write in candidate for each office shall appear on the ballot.

Article XIII – Elections

Proposed adding Section 7: *The order of the names of candidates that are printed on the ballot will be determined by a chance drawing. The drawing shall be witnessed and certified by the members of the Nominating Committee.*

Rationale: Voters who do not have a preference typically vote for the first name on a ballot. Roberts Rules suggests that to avoid position bias the order of the names on a ballot should be determined by a random process.

If amended will then read: The order of the names of candidates that are printed on the ballot will be determined by a chance drawing. The drawing shall be witnessed and certified by the members of the Nominating Committee.

Article XIII – Elections

Proposed adding Section 8: *All members seeking an elected office in the San Gabriel Valley District of Women’s Clubs/SGVD will be given an opportunity to give a two (2) minute speech on their qualifications to members of the Executive Board the meeting prior to the election.*

Rationale: To ensure delegates have an opportunity to learn about the candidate prior to the election in order to make a more informed decision. To ensure candidates have an opportunity to tell members about their qualifications before a vote is taken.

If amended will then read: All members seeking an elected office in the San Gabriel Valley District of Women’s Clubs/SGVD will be given an opportunity to give a two (2) minute speech on their qualifications to members of the Executive Board the meeting prior to the election.

Article XIII – Elections

Proposed adding Section 9: *All members seeking an elected office in the San Gabriel Valley District of Women’s Clubs/SGVD be required to provide to the Nominating Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women’s Clubs/GFWC - California Federation of Women’s Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words. The Nominating Committee shall create a document containing all of the Candidate Statements and email them to all delegates no later than one (1) week prior to the election.*

Rationale: To ensure delegates have an opportunity to learn about the candidate prior to the election in order to make a more informed decision.

If amended will then read: All members seeking an elected office in the San Gabriel Valley District of Women’s Clubs/SGVD be required to provide to the Nominating Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women’s Clubs/GFWC - California Federation of Women’s Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words. The Nominating Committee shall create a document containing all of the Candidate Statements and email them to all delegates no later than one (1) week prior to the election.

Article XIII – Elections Proposed adding Section 12: *Any candidate that is nominated from the floor on the day of the Election will have the opportunity to give a two (2) minute speech on their qualifications and provide their candidate statement to delegates at the meeting at which they are nominated.*

Rationale: To ensure delegates have an opportunity to learn about the candidate prior to the election in order to make a more informed decision.

If amended will then read: Any candidate that is nominated from the floor on the day of the Election will have the opportunity to give a two (2) minute speech on their qualifications and provide their candidate statement to delegates at the meeting at which they are nominated.

Article XV- State Endorsements

Proposed added Section 2 and renumbering sections as needed. *Members of the San Gabriel Valley District requesting the Executive Committee consider endorsing a member including themselves for a CFWC or GFWC position shall submit to the Executive Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women’s Clubs/GFWC - California Federation of Women’s Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words.*

Rationale: To ensure Executive Committee members have an opportunity to learn about the candidate prior to the Committee’s approval of writing a letter of endorsement.

If amended will then read: Members of the San Gabriel Valley District requesting the Executive Committee consider endorsing a member including themselves for a CFWC or GFWC position shall submit to the Executive Committee a Candidate Statement that includes: Name, Club affiliations, Years in Federation; positions held at the Club level; positions held in the San Gabriel Valley District/SGVD, positions held at the General Federation of Women’s Clubs/GFWC - California Federation of Women’s Clubs/CFWC, position the candidate is running for and a candidate statement of up to 250 words.

Proposed added Section 3 and renumbering sections as needed. *After the Executive Committee has completed the process for approving the writing of a letter of endorsement for a CFWC or GFWC position, if an additional person(s) make a request for a letter of endorsement at an Executive Board meeting, all potential members to be endorsed will have the opportunity to give a 2-minute speech prior to any vote being taken by the Board to approve the submission of a letter of endorsement on behalf of the SGVD.*

Rationale: To ensure voting delegate have an opportunity to learn about the candidate prior to the Committee’s approval of writing a letter of endorsement.

If amended will read: After the Executive Committee has completed the process for approving the writing of a letter of endorsement for a CFWC or GFWC position, if an addition person(s) make a request for a letter of endorsement at an Executive Board meeting, all potential members to be endorsed will have the opportunity to give a 2 minute speech prior to any vote being taken by the Board to approve the submission of a letter of endorsement on behalf of the SGVD.

Article XVI – Amendments

Proposed adding Section 3: *The Bylaws may be amended at the Convention by a two thirds vote of delegates in attendance.*

Rationale: There is currently no language that defines the vote necessary to approve proposed changes to Bylaws.

If amended will then read: The Bylaws may be amended at the Convention by a two thirds vote of delegates in attendance.

Proposed Change: Any SGVD member sending a mass ~~an~~ email defined as ***any email message sent to the entire group or large subset*** for the purpose of sending general information such as an announcement of an event that does not ask for/need a response and a majority of people being emailing don't know each other ~~to members or a group of members~~ shall be requested to use the BCC option. When a message is sent to a group of members that may require a response the BCC option will NOT be used unless requested by individual member(s). Those who are Bcc'd are expected to not respond since the other party doesn't know they were included or were privy to the conversation. The use of Bcc shall be included as a notice to those receiving the email.

Rationale: Several members are concerned about the inclusion of their email address in messages sent to members. They want to protect themselves against receiving unnecessary replies, viruses and spam. They would like all emailed communication from the District to use the Bcc format. Others are concerned that using the Bcc option is a sneaky or underhanded way to create a paper trail and is a violation of trust. They want to be sure that their replies to any message are only sent to people whose names are listed as recipients to the message. A Standing Rules needs to balance the concerns members.

If Amended would Read: 2. Any SGVD member sending a mass email defined as ***any email message sent to the entire group or large subset*** for the purpose of sending general information such as an announcement of an event that does not ask for/need a response and a majority of people being emailing don't know each other, shall be requested to use the Bcc option. When a message is sent to a group of members that may require a response the Bcc option will NOT be used unless requested by individual member(s). Those who are Bcc'd are expected to not respond since the other party doesn't know they were included or were privy to the conversation. The use of Bcc shall be included as a notice to those receiving the email.

A good newsletter is an excellent means of promoting the organization. It reflects the club's image, goals, actions, and areas of concern. A newsletter should also be used as a tool to educate the members about Federation. A copy of the newsletter should be provided to any prospective member to inform him/her of Club and Federation activities. Each club is asked to deliver copies of its newsletter directly to the District President, 1st Vice President, 2nd Vice President, Corresponding Secretary, and Public Relations/Communications Chairperson. This may be done by email, U.S. Mail, or hand-delivery to their folders in the Communication Box at District meetings and councils.

Guidelines for Club Newsletters:

1. The front page of your newsletter should contain:
 - The name of your organization
 - The month and year of publication
 - Club President's name, theme, and symbol
 - Newsletter Editor's name and contact information
 - Federation logo
 - Calendar of events
 - President's message
2. The second page should begin with reports from your Club Officers, in the order listed in your bylaws.
3. Federation facts, inspirational messages, etc. may be inserted between Officer's reports.
4. Chairperson's reports should follow Officers reports.
5. Club Newsletters should cover International, State, and District activities. Watch for events and check the CFWC and GFWC websites.

Judging Information:

1. Any club wishing to enter the District Club Newsletter Contest will turn in four (4) copies of its best issue, published from January 2022 thru December 2022 to the District Public Relations & Communications Chairman by January 13, 2023.
 2. No reports are needed from the individual clubs.

Happy 2023 New Year to all.

Nancy Krueger here.

I am a certified Health and Wellness coach with the Dr. Sears Wellness Institute with specialties in Adults and Seniors, Families and Pregnancy with certificates in Nutrition. I am also a personal fitness trainer and fresh vegetable and fruit juice therapist. The Health and Wellness motto for this term is...Make Health Your Hobby. We all need a hobby, and the older we get, the more important hobbies become.

This month's theme is focused on the basics of eating physiology for optimal nutrition as a part of holistic wellness: The Rule of Two's. This is some of what that consists of: Eat twice as often, Chew twice as long and Eat half as much.

Let me give a brief explanation of these behaviors to practice when thinking about your nutrition.

1) Eat twice as often means small meals. The health benefits are to fuel the Brain, reduces stress, burns fat, improve digestion and keeps a steady supply of fuel and insulin to your system.

Grazing is eating small meals throughout the day. 2) Chew twice as long slows us down when we are eating. That method increases body awareness with mindfulness, it makes food more enjoyable, it slows digestion, creates less air. Chewing for smaller pieces help with less reflux and constipation too. 3) Eat half as much is keeping in check on how much each meal should be.

An adult portion is the size of your fist or a single food is also a portion. For example, one apple is a single portion. As we age, the more nutrient dense foods to seek out and appropriate portions to that meet your daily functional requirements which enable you to do whatever it is you that you desire to accomplish in life.

One more part of Health and Wellness in a holistic manner is practicing the art of gratefulness. In your morning prayers...add thankfulness.

In American Heart Association News in their publication on, Gratitude is a Health Attitude states, "Clinical trials indicate that the practice of gratitude can have dramatic and lasting effects in a person's life. It can lower blood pressure and improve immune function. ... Grateful people engage in more exercise, have better dietary behaviors, are less likely to smoke and abuse alcohol and have higher rates of medication adherence."

Thank you clubs for sending in a Women's History Report. I enjoyed reading them and look forward to acknowledging your efforts in April at our District Convention. If you want to know where our organization is heading, study the history of the General Federation of Women's Clubs. The old saying, "history repeats itself" is certainly true when you look at our beginnings in the 1890's and compare them with what we stand for in 2023! The core values of the GFWC have changed very little over the last 133 years. "We are an international women's organization dedicated to community improvement by enhancing the lives of others through volunteer service. Collectively, we are Living the Volunteer Spirit."

At the December 9, 2022, District meeting I introduced two new projects that I am asking clubs to consider adding to their women's history section. Here is their description.

"Writing Women Back into History one Book at a Time"

Start a tradition and donate books about women. The National Women's History Alliance (NWA) is encouraging organizations and individuals to "gift" a book about women to a local school or library. Patsy and I will provide you with a book (free). We have five titles you can choose from. You will deliver the book to a local school or library and donate it to their collection. Explain that including women in history can bring about social change. Once delivered, send Kim Plater an email (kimplater@aol.com) or a note (10 Comanche Circle, Pomona, Ca. 91766), letting her know you delivered the book(s). You can also gather additional books from family, friends, bookstores, members, and if you have a book club see if they would be willing to donate a book. Expand your project to encourage the library/classroom, to celebrate women during Women's History Month (March); invite a library staff member to join your club; make it a quarterly or yearly event; celebrate Women's History Month at your meeting with a "moment" about the book(s) you "gifted." In return for the free book, we ask you to submit a narrative report about your project under the WHRC category (due in January 2024). Also consider asking members, family and friends, bookstores, or others to donate a book. Take a few members with you to deliver it or send it with a note describing the project. Check with the location in advance if you are going to visit in person. Really want to make it special for someone in your club? Do you have a member who is a retired teacher or librarian that does not come to meetings for various reasons? Offer to pick her up and take her with you or call her and tell her about the project and offer to make the donation to her library or school. There is a limit of one book per club. We'll be in the lobby distributing the books on January 13, 2023. Clubs that participate will receive a gift.
