
President's Message—Gina Morales (562) 405-4461

For many of you, your fiscal year has just ended or is about to. Summer is a good time to do the state and federal filings. Here is the checklist of what you should file:

DUE DATE for all submissions: 15 th day of 4 th month of fiscal year (example – fiscal year ends April 30, filing deadline is August 15.

- ☐ Federal 990 (990n) Federal Return Can be filed electronically for free
- □ CA199 (199n) State Tax Return Can be filed electronically for free

- ☐ CA CT-TR-1 Annual Treasurer's Report
- □ CA RRF-1 Annual Registration Renewal File with CA CT-TR-1/fee \$25

I keep a worksheet in my nonprofit filings folder to make the process easier. It has the District's EIN and Corporation number, club address, etc. That way I don't have to dig up that information each time I'm filling out the various forms. If you think this might be useful, I've attached a downloadable copy of the worksheet in MS Word format.

Most clubs use Cash-basis Accounting (one of the boxes on the Annual Treasurer's Report CA-CT-1). If you have receivable; payable; or prepaid accounts, your books are set up on Accrual-basis. If you pay bills as they come in, you are Cash-basis.

Be sure to accurately record your Club's Assets. That is anything that can be liquidated for cash and includes cash in the bank, savings accounts, money market accounts, and CDs. This should be a breeze if you've kept the clubs accounts up to date.

Need help? Email me. Working together, we can all make the jobs of the Club Financial Teams easier and sometimes fun.

Your SGVD financial team (Yvette Romo, Financial Secretary, and Shari Kovach, Treasurer) have big plans for the Financial Team Forum that will start in the Fall.
